Review of Treasury Report: Erik Smith and Barrie Rojahn

Delinquency report of unpaid HOA reviewed and explained in detail by Barrie. The board voted to update the current Collection and Lien Policy. Pool and parking lot - Security camera contract reviewed. The board voted to terminate the expiring 36 month maintenance contract with the current company. We own and operate all equipment in place (cameras, PC, etc.).

Discussed violations of homeowner covenants concerning maintenance mainly of home fronts and property appearance. Letters have been and will continue to be sent as needed. Going forward, the Board is determined to take an aggressive stance to keep our neighborhood well maintained.

Social Committee Report - Annual Easter Egg Hunt is March 24. Discussed possible future events including Fishing Derby in tandem with the Boy Scouts, Memorial Day Party at C1 pool, July 4 Event, Family Movie Event and Adult Pool Parties. Cedarfield II Board Meeting Minutes — March 2013

Attending: President: Emily Biggs; Vice President: Kevin LaValley; Member-at-Large: Gary Wilt; Secretary-Treasurer, Ray Kudlak; copies to: William Carter; Barrie Rojahn, Hawthorne Mgmt.

The meeting was called to order at 7:02 PM and the previous Minutes were adopted.

Treasurer's report - The Hawthorne Management financial report for February was reviewed and discussed. Hawthorne Mgt. provided details for three charges: Administration, Late Fees and Payment Plans. Of note was the credit to the Budget in the amount of \$5000 for refunding our legal retainer. In addition, Hawthorne will be providing the independent audit of our books which should be completed by the April meeting.

Board Member, William Carter has left the Board and will be missed by all. A **BIG THANK YOU** to Bill for his volunteerism and participation in the past Board meetings!

New Business - A new Website address for the Cedarfield 2 Website is up and running thanks to efforts by President Emily Biggs. You can find the site at (<http://cedarfield2.com>).

Due to the resignation of Bill and potential new additions to the Board, appointments of new **Board members** and confirming existing members will be delayed until the April 10 meeting.

Old Business - The **Sandwich Boards** we now use for announcements will be repaired or replaced. A permanent **Message Board** structure for posting events for the community, possibly placed at the Pool is being explored with 3 suppliers.

Pool Committee - Pool Entry Fobs will be issued to new C2 households, Outside Members and for lost Fobs on April 13 and April 20 at the C2 Pool from Noon to 2 PM. Payment is due at that time. Costs are \$15 per Fob, including lost Fobs or additional Fobs with a maximum of 2 per C2 household, only.

Fobs are permanent and will be used annually - therefore, **DO NOT** discard your Pool Entry Key Fob at the end of pool season!

Outside Pool Memberships will be charged **\$50 per season per household plus \$15 for the Key Fob.** Current Fob holders must make their \$50 Outside Membership payment direct to Hawthorne Mgt.

All C2 homeowners and Outside Members in good standing will have their Fobs activated when the Pool opens. See the above paragraph for dates and times to obtain new, replacement or lost Fobs.

The **Cedarfield Swim Team Shark mascot** is out for re-painting and caused quite a stir for onlookers as it was being transported by truck to a local auto body shop!

It has been determined that no action is necessary until more information is obtained to address the installation of **Handicapped Lifts.**

Landscape Committee - Two "Dog Waste Stations" will be installed. These will be serviced by our landscaper and will consist of disposal bags and a disposal receptacle. Locations will be on McIlwayne, midway between McCoy to Stratton Farm and Stratton Farm across from the C2 Pool.

Architectural Committee - The **volunteer members** for the ARC committee are doing a **great job!** Their involvement has resulted in many improvements being made by homeowners to their properties.

RECYCLING COLLECTION

Recycling collection is handled by Advanced Disposal and will be collected every other week on your designated pick-up day. Recycling must be curbside by 7:00 a.m. on your collection day. The method of collection is Single-Stream, so all recyclable items (see list below) can be placed into your 96-gallon rollout cart.

- Metal Cans (aluminum or steel), including soft drink, beer & food cans.
- Rinse out cans.
- All Plastic Containers except #6, including soft drink, liquor bottles, milk jugs and
- Detergent bottles. Rigid Plastic Containers (toys, litter boxes, buckets) will also be collected.
- Glass Bottles & Jars: Clear, green and brown glass is acceptable. Remove caps & lids and rinse out.
- Newspapers, Magazines, Catalogs, Phone Books, Junk Mail & White Paper: When recycling these items, please separate them from other recyclables by placing them in a paper bag and stacking them beneath or beside your recycling bin.
- Cardboard (flattened)
- Recycling that does not meet the above criteria will be tagged as non-compliant. If the resident makes household garbage conform, it will be collected at the next regularly scheduled pick-up.



Residents can also drop off recyclables Tuesday-Friday at the North Mecklenburg Recycling Center located at 12300 N. Statesville Road. For more information, call (704) 875-1563.

- ◆ If you were not a member last year and would like to join this year, please mail your check for \$50 for membership and \$15 for the pool fob and mail that to the above address, Attn: Barrie Rojahn
- ◆ Pool fobs will not be activated if your assessments are delinquent
- ◆ Pool fobs will not be activated until \$50 outside membership fee has been paid for 2013

Neighborhood Discussion

From the CII Facebook Page in March:

Posting from March 18th:

Many residents were wondering what is going on with the construction on the greenway. Mayor Jill Swain chimed in on this FB group wall and gave us the scoop! Here's what we learned:

From Mecklenburg County regarding greenway construction:

The construction in the area of the greenway at this time is Piedmont Natural Gas installing a new line. In fact, we must wait on them to finish before we can start. Greenway construction should be active within the next several weeks...I am hoping by June. The greenway construction should take about 9 months to complete. The greenways in your area are finally getting taken care of. The vision (with the County as a partner) is to eventually have a town-wide interconnecting greenway system. Our portion of the greenway will eventually connect to Rosedale. They're connecting all of our greenways. Winfield and up Ranson road and Gilead too .

Another thing on people's minds: **Fluoride in our water.** Some resident's have been sharing their concerns that this is VERY dangerous and unconscionable for our town to add fluoride to our water system. Mayor Jill Swain posted the following on March 16th: Many of you have recently received inquiries related to the fluoridation of Charlotte-

Mecklenburg's drinking water supply. At the recommendation of the Mecklenburg County Health Department, we add fluorosilicic acid (fluoride) to the drinking water during the treatment process. Our program has been in place since 1949, and our partners in the medical community feel it is an important part of protecting public health. In fact, the Centers for Disease Control and Prevention named community water fluoridation as one of the "Ten Great Public Health Achievements of the 20th Century."

There are several options for adding fluoride during the water treatment process, and we use fluorosilicic acid (FSA) because it is quickly soluble in water. FSA feed equipment also requires less maintenance and consumes less power during operation. FSA used by CMUD meets standards set by the American Water Works Association and is certified by NSF International, an organization that certifies products and writes standards for food, water and consumer goods.

In 2011, we reduced the amount of fluoride CMUD adds during the treatment process after guidance was issued by the Department of Health and Human Services. Sidestepping Solicitors

Annoyed by the persistence of solicitors' unwelcome knocks on the door? It seems like no matter what they do, they always manage to show up on your front porch. They come with fliers, door hangers, a rehearsed speech and the distinct ability to ignore the polite decline of the products they're peddling—cleaning supplies, appliances, cosmetics, magazine subscriptions, home-improvement products, coupons for local businesses and other unwanted items—sometimes even making you feel trapped in your own home.

Homeowners associations are particularly easy, frequent targets of commercial, religious and political solicitors; part of the appeal is that population density makes our association an easy environment for them to canvas. Because of this, finding a way to keep solicitors away can be invaluable.

The simplest way to deter solicitors is by posting a "No Solicitors" sign in your yard, on your door or in your front window. If you get knocks on the door anyway, **you also can ask solicitors for their license, permit or company identification**; many don't have it and will leave. If the solicitor doesn't leave or keeps coming back, tell them the community has nuisance restrictions and there are legal ramifications for violating them. And

if that's not enough to make them high-tail it off of your lawn, you can also call the police, and ask for them to escort the solicitor out of the community.

While a visit from a solicitor is often annoying, they can sometimes be more than just a nuisance; some might have ulterior motives, such as fraud, canvassing a home

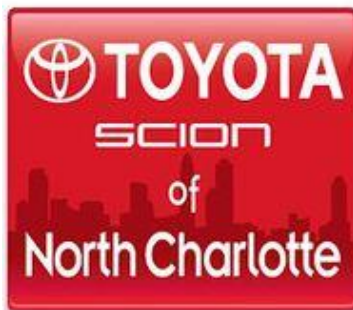


to commit a crime or other unseemly behavior. If you believe a solicitor is acting suspiciously or you feel threatened, call the police immediately and notify our security personnel to help you avoid a potentially dangerous situation.

So stay safe, keep your sanity and do your part in discouraging solicitors from trolling our community. You'll soon hear just how sweet an un-rung doorbell sounds.
