

## CII ANNUAL HOA BOARD MEETING

**January 8, 2018**

Six additional community households present – a quorum was not able to be established (41 lots needed).

## **COMMITTEE REPORTS**

- Pool Committee A review of the current fob system is underway by the Pool Committee to eliminate excess pool fobs in circulation. As a reminder, there is a no overnight parking policy in place at the C2 pool. Any vehicles parked overnight will be towed at the Owner's expense. If additional overnight parking is needed, contact a Board Member for approval.
- **ARC Committee** Any changes to property must be approved by the CII ARC committee. The purpose of the approval process is to ensure property changes & improvements conform to the existing architectural tone of the community as set forth by the Covenants, Conditions, & Restrictions set forth by the HOA. - Social Committee The Cedarfield Christmas festival held in December was very successful. Although a combined event with CI, CII picked up the entire cost of the event which totaled \$4,000. - Landscaping/Maintenance Committee The Board is currently looking into options for cleaning up the creek bed in the power line right-of-way area. The bed is part of the area watershed boundaries and we are looking for assistance from the Town to ensure cleanup is handled properly. The current C2 playground has been closed indefinitely due to major structural and safety concerns. The Board is currently working to find replacement options that are up to current safety codes & regulations.

## FINANCIAL REPORT

Cedarfield II is finishing 2017 within budget, with a slight surplus due to unanticipated SUN advertisement sales, paid HOA late fees, & various other means. The 2018 budget has been approved and is very comparable to the 2017 budget. Some homes have prepaid excess amounts of HOA dues; homes with excess paid amounts at the end of the 2018 dues cycle will be reimbursed back to the homeowners. \$15 late fee will continue to be assessed for late HOA payments.

Due to a quorum not being established, the Board appointed Abby Barton for an additional term as the Board Member at Large, through 2019.
