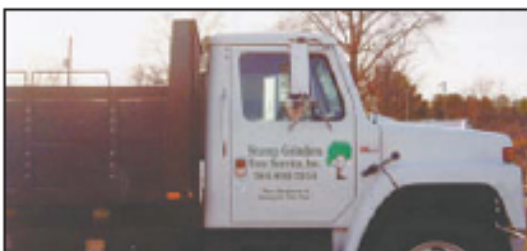

HOA MEETING MINUTES

April 21, 2020

Call Meeting to Order at 7:03pm

In attendance: Jerry Goedert (President), Addy Barton (Vice President), Doug Schultz (Secretary), Dave Mullaly (Member at Large), Bob Creighton (Treasurer), James Phillips (Landscape/Maintenance), Sue Sink (Pool), Sue Patrick (Hawthorne Mgmt), Eve Smith (Social), Mary LeValley (Swim Team), and Holly O'Connell (Homeowner).

Motion to ratify the March minutes; was seconded, motion passed.

OFFICER REPORTS

Treasurer Report: Total Cash on hand at March 31, 2020 was \$143,175, compared to \$151,755 one year ago and \$129,629 last month. Overall reserves increased \$2,105 from \$39,606 to \$41,710. Year to date Assessments through March 2020 were \$124,709 compared to \$111,989 in 2019. This appears that 2020 assessments have been paid at a stronger pace compared to the prior year, however it is noted that \$26,231 of 2019 assessments were prepaid in December 2018 whereas only \$5,559 of 2020 assessments were prepaid in December 2019. As a percentage, through March 2020 we have collected 67% of the full year assessment, compared to 71% the prior year. Unpaid assessments at March 2020 were \$9,287 compared to \$16,569 last month and \$8,764 a year ago. Year to date cash expenditures through March 31 were \$44,279 compared to \$34,507 in the prior year and budget of \$36,602.

President Report:

- Pine fines are basically done and looking great. Lots of compliments.
- Disclaimer about me purchasing Pine Fines from James (President bought the Pine Fines product for his residents)
- Posted on FB about James to offer Pine Fines to the community (Landscape has made the Pine Fines product available for purchase for any homeowner whom wishes to purchase. Contact: james@phillipsenvironmentalsolutions.com.
- Verizon tower Update project with Chase: Requestor is still working on construction budget cost.
- We received one complaint letter about music and many compliments.
- Responded to letter with HOA has no rule about it
- Was asked to stop it – can't, this would be a City/County issue, and the complainant would need to contact those authorities.
- Was asked to sanction it or put at the pool parking – didn't do either

UNFINISHED/OLD BUSINESS

- Gaga Ball Pit –**Tabled until May**
- Campaign to promote New Info Page – **Tabled to May**
- Repair Swing Set Grounds –**Tabled to May**

COMMITTEE REPORTS

- **LANDSCAPE/MAINTAINANCE:** Pine Fines 98% completed (all entrances/monuments 100%). Light on Moon Shadow has damage & is being addressed. Monument flood light at Stratton Farms & McCoy has been adjusted to only shine at monument and not at drivers. Lighting strike issue being addressed. Water leak at Henderson Hill and McIlwaine Rd has been addressed and is being monitored. Homeowner raised concerns (safety, airflow, bugs) about shrubs at the fence at the far (deep) end of the pool. Due to cost, Covid-19, and possible short pool season the Board has Tabled this discussion until next year.
- **ARC COMMITTEE:** Fencing request was made –Approved.
- **SOCIAL COMMITTEE:** Community Spring Garage Sale Cancelled. Memorial Day Event moving forward currently. Homeowners have asked about Corn-Hole events at the pool this summer. The Pool Committee sees no issue, but it must be a Homeowner setup, organized, equipped, and driven event.
- **POOL COMMITTEE:** Pool Deck repairs completed. Passed county inspections after replacing lost Life Saving Buoy, and damaged/weathered safety signs. A couple of lounge chairs still need to be re-strapped.
- **SWIM TEAM:** Discussing schedule for the possible shortened season and waiting on contracts.
- **WELCOME COMMITTEE:** No closings in the last month. Looking at possible new sponsor(s) for "Welcome Bags".

Board Attendees: Heather Bankert, Ben Barbour, Brian Summers, Pat Beare

Motion with second to ratify March Regular Session Minutes; all in favor. Motion Passed

Statement from HOA board on Covid-19: We will not charge late fees or send Past Due notices until the Stay At Home Order is lifted

Financial Report

- We're maintaining a healthy operating balance and we have \$41K in reserves
- Pine straw was \$6K
- Upcoming pool repairs around \$2K

Committee Reports

- Landscaping
 - o Statement from Superior, Krista attended
 - No restrictions of work they can do – mowing, treating of grass, projects, etc. will continue
 - They will shovel out clay on sidewalk areas along Stratton Farm. If that doesn't work, we can regrade sections of low-lying areas and add river rock
 - o Pine straw was laid down – we missed a Cedar River and Cedar Fall island, but will add it
 - o Tarp at Moore's Mill: Tarp is covering the displaced dirt; We can't find the leak, so we think it's under the road and we have to get the Town involved to dig up the road. Ben will reach out to the Town soon
 - o Twin Trail leak – almost 2 years of fighting with City of Charlotte to fix the meter. There is a leak in the valve box, which we can shut off because we can shut off the backflow valve. However, the backflow is in very bad shape and is unlikely to be approved for use by CLT water and needs to be replaced, which requires the meter to be replaced, but we haven't gotten anywhere with that.
 - o Annual vs. Perennial flowers
 - We have had an issue in the past stealing our flowers
 - With the annual option we would spend about \$6K per planting, and we would do that twice per year
 - Now we have more greenery/natural so we don't have to keep planting around Entrance
 - We are talking about improving the islands before we redo the entrance, thinking of starting at Angel Oak because many bushes dead
 - Also plan to cut the mushroom hollies to a more maintainable height
 - o Mulch vs. Straw
 - C2 just switched to mulch vs. straw.
 - Not necessarily much more expensive over time, but has to be handled differently; We will price the difference
 - o Homeowner Marien complained about plantings at entrance and dilapidated fence on McCoy
 - o Homeowner Wendy: lives on Harlow Creek, her yard backs up to greenway trail and landscapers blow debris into her yard and limbs. Krista will make sure her workers do not dump on this area. We can also add a "no dumping" sign

- Also requested survey by HOA for what is property line. We plan do a survey of all HOA property, especially all that borders HO property – delayed by Stay at Home order
 - There's a green pipe that doesn't seem to work for overflow at the pond. We will ask our pond inspector to check all pipes, looks like they missed that one
- Social
 - Easter Event had be cancelled
 - No other events booked due to uncertainty; we will move forward as soon we can
- Technology
 - We successfully conducted our first Zoom HOA meeting!
- Pool
 - Necessary pool repairs –
 - broken valve around \$1500
 - Also have a leak at the meter, we think belongs to City of Charlotte but no movement from them yet. No water without this repair = no pool
 - Skimmers in back left of the pool not working either
 - Will we be able to open? At this point still planning to open Memorial Day weekend, but only if Stay At Home order lifted
- Miscellaneous
 - Cedar Management not doing inspections until Stay At Home Order listed because not essential
 - Homeowners can still make complaints
 - CMG does the violation inspection but the board approves
 - Vacant board position (no vote at this time)
 - Steve Hilliard resigned
 - Board will appoint a new person so let us know if you are interested – will serve the rest of Steve's term but subject to election at January annual meeting
 - Homeowner wants on the record that she complained to the board about Steve Hilliard's violations and then he used that confidential information against her
 - Board will have to consider new plan to render useless board members who don't participate and/or abuse their power
 - At this point, only the community can remove a board member (not the board) – which requires a majority vote of the members of the association
 - We are consulting our attorneys whether our by-laws are superseded by NCGS that allow majority of votes at meeting
 - We may put to vote at annual meeting a procedure to remove board members especially those who commit unethical behavior
 - Homeowner Chris D asked about switching garbage provider, but garbage pickup is handled by the Town

Next meeting date Tuesday, May 5 at 7 via ZOOM.

- **Connect with others.** Talk with people you trust about your concerns and how you are feeling.



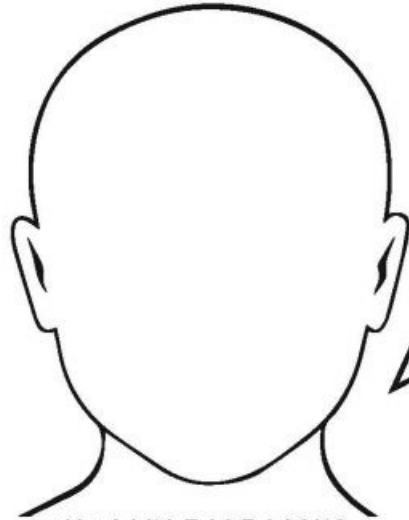
