# **OFFICER REPORTS**

<u>Treasure Report</u>: Total Cash on hand on October 31, 2020 was \$96,693, compared to \$78,308 one year ago and \$109,639 last month. The Total Cash: Unrestricted cash at 10/31/2020 was \$51,974 compared to \$47,444 one year ago. Year to date cash expenditures through October 31 were \$142,280 compared to budget of \$148,340 and prior year of \$168,328. The full annual assessments have been paid by all homeowners except 4. Thank you to everyone who is now current, especially in this tumultuous year.

October expenditures included these items worth mentioning:

- 1. Final repairs to the women's restroom were paid in October, for \$3,643. This brings the total repairs to \$7,101, some of which qualify for reimbursement by the insurance company which was \$3,752.
- 2. We paid \$1,304 to Phillips Environmental for replacement of the wood border around the swing set and to move mulch from the old playground area to the swing set. The mulch at the old playground could not be salvaged.
- 3. We paid \$846 relating to Social Committee activities. Of this, \$513 was late billings relating to summer activities and \$333 were for the Trunk or Treat held on October 25.
